Welcome

Loucas opened the call and noted that Congress is in recess so there will not be a Washington DC Update.

Advocacy Issues

From time to time, MRS has been asked to join as a signatory on letters regarding policy issues or appropriations support. On issues where MRS has an established policy, GAC is not usually asked to review the request. But when an issue arises that is novel or has a sense of urgency, GAC will be asked for feedback. MRS has received a request from IEEE-USA to sign on to a letter to the Office of Science and Technology Policy (OSTP) requesting P-2 Priority designation visas for volunteers and members of global professional societies to facilitate their evacuation from Afghanistan. Given the timely nature of what is transpiring in Afghanistan, it is recommended that MRS signs onto the letter. All GAC members present in the call voted in favor. The letter will be sent for approval by the MRS Executive Director and MRS President. There is a record of advocacy letters on the MRS website: https://www.mrs.org/advocacy-policy/policy-issues

MRS co-sponsors two Congressional Fellowships, one with OSA (The Optical Society) and the other with TMS (The Minerals, Metals & Materials Society). The Advocacy Subcommittee is responsible for selection of the MRS/OSA and MRS/TMS Congressional Science and Engineer Fellows for assignment as a special legislative assistant on the staff of a member of Congress or congressional committee. They have a robust Fellows network and try to keep them engaged with what is happening in the Society and with advocacy. Typically there is a fellowship breakfast and one is being planned for this year, time/place TBD. Due to COVID-19 there are some protocols to follow based on local guide lines. Although we typically don't lobby the fellows, there will be opportunity to interact with them. More information to follow.

Working Group Reports - Roadmap to activities for the rest of the year

Boris Dyatkin reported that Materials Voice activities will resume at the 2021 Fall Meeting. The plan is to have the kiosk located close to meeting registration to allow for a more organic flow of meeting attendees to participate. Several topics are the focus:

- Budget and appropriations we typically have ask numbers and try to reinforce to appropriators, however, the Biden budget may pass in the next few weeks. The writing team is assigned to this. A 2nd letter will be directly related to the DOD
- USICA and passage in the House
- Funding for ARPA-E
- Fusion of nuclear thermal issues framed as investing in technology and collaborations.
