2021 Review

- Appropriations letters for DOD, DOE, NSF, NDAA funding
- Response to Executive Order on Combating Race and Sex Stereotyping

Through Materials Voice, personalized letters addressed to member's representatives on Capitol Hill were made available to express support for basic research funding, increased funding for DOD basic research, and the US Innovation and Competition Act. In addition, the popular postcards that highlight the value of materials successes driven by federal research investment continued.

Signature Events

CVD (Congressional Visit Day) late April/early May – deadline to send first round of invitations is Feb. 21. A fall CVD is also being considered.

Government Agency Leadership Summit – possibly late May depending on CVD dates. Looking to possibly expand participation by including other professional societies (ACERS, AiCHE, etc..)

May 8 - 13 is the **2022 MRS Spring Meeting** in Hawai'l. There are no concrete plans for face-to-face meetings in Hawai'i. The status of federal travel restrictions is unknown but if they are lifted, face-to-face meetings may be possible. A record number of abstracts for S22 have been received and a majority of the speakers prefer to present in person.

Grass Roots Advocacy Working Group

Final throes of completing a white paper on fusion materials which will be ready for a final look by GAC leadership and full GAC soon. MRS will be adding some graphics to the paper.

Policy Outreach Working Group

The Policy Outreach Working Group agenda is focused on CVD and the Government Agency Summit. There is no status on USICA and the Build Back Better Bill has failed to pass. There have been conversations about breaking the Bill up into smaller pieces. In particular, MRS cares about the funding for NSF, DOE, DOD.

Loucas thanked Sean for spearheading the fusion materials white paper. Jeffrey Aguiar reported that he is reviewing a draft paper on space materials and will send it along shortly.
