Topical Curation Subcommittee F24 Report – Julia

This is Julia's last report to this group as her term has ended; Al Hurd is the incoming TCS Chair Look for areas that continue to be vibrant, emerging topics, topics that have fallen off F24:

81 proposals submitted

Good topical coverage

- Review of several topics: See full TCS report
- Recommend symposia on Epitaxial Oxides, and related to the CHIPS act
- Missing topics: Fusion Materials, Cement and other old/traditional/less exotic materials, Emerging Industries

- Several newer fields represented (i.e., bulk metallic glasses, materials in extreme conditions)
- Characterization cluster is now a mainstay in MRS Meetings after recommendation by TCS In the longer term, special attention should be paid to:
 - topics that have had a long presence but don't spontaneously submit a proposal (need to be solicited/prompted)
 - look after vibrant topics so they don't disappear

Improved overall from previous meetings

Impressed with international participation

Industry involvement remains low, even in Applications and Manufacturing

- Recommendation to listen to feedback from industry and loyal volunteers who are no longer involved
- Promise of partnering with other societies to bring in Industry is fundamental to some areas (i.e., Applied)

Structure is in place and the ideas are there, but don't know how to achieve these operationally

Suggested MRS consider hiring a dedicated staff person for Industry

Focus on Sustainability - Elizabeth

Expressed appreciation for the contributions of Natalie Larocco, who recently left MRS Focused on George Crabtree Tribute, 2050 Panels for F23 and S24, and interim events before S24 Discussions are underway about the amount of grant funding that will remain at the end of this year as well as future options when the grant is spent. Elizabeth and Michele will discuss this in more detail offline.
